

## Home Equity Line of Credit Funds Advance Request Form



- In no event shall PHH Mortgage be responsible for any consequential or special damages resulting from any error committed by PHH Mortgage or any other person with respect to the transfer or any failure to complete the transfer, even if PHH Mortgage has been advised of the possibility of such damages. In the event PHH Mortgage has complied with the instructions below and the transferred funds are not received, PHH Mortgage's only obligation is to re-credit the undersigned's Line Agreement for any portion of the transferred funds actually re-credited to PHH Mortgage.
- PHH Mortgage has no obligation to accept the instructions below and may, at any time, advise the undersigned that PHH Mortgage is unable to initiate the contemplated transfer, for any reason.
- The undersigned may only cancel the transfer instructions below if the cancellation instruction is received by PHH Mortgage at a time and in a manner affording PHH Mortgage a reasonable opportunity to act prior to effecting the transfer.
